Good morning,

I'm afraid I have to agree with Senator Stedman in his Bravo Sierra comment this morning. Also, as Senator Hoffman said, the bridge funding – the over-draw – is a great concern. I do not agree with making an unsustainable draw from the Permanent Fund.

Even if there was a future incident such that a one-time draw would be somewhat defensible that would not be this time when we have a comfortable recovery under way (as evidenced by labor shortages, price and wage inflation, etc.) and unprecedented federal spending here. All I see that recommends an extraordinary PF draw now is that next year is a big election year, and that is a terrible reason to over-draw.

Government spending at the federal, state and municipal level is apparently decided without regard to bringing erosion of self-respect and personal responsibility, and I see that erosion manifested in contemporary social problems like opioid abuse, mass murders, and the erosion of military defense system performance. As so many Americans point out, the United States could not win WWII today, and I see the social ills that come from government spending as part of the reason.

As a life-long student of economics I am not a fan of the PFD, chiefly because the IRS take is so large and immediate. However handing out money has many fervent adherents, and I believe that the state annual spend is so large that it inhibits and retards our private sector economy. Therefore there is a trade-off tension to consider

between spending on state government responsibilities and wants, and the PFD. The erstwhile Governor badly damaged trust that long existed in determining the annual PFD amount, and now a fifty-fifty split may need to be evaluated.

Thank you for all your hard work. Thank you for your time. I am very sorry that you are spending so much of this year in session.

Thank you for this opportunity to testify.

I am writing in support of SB 53. My belief is that the Permanent Fund was established to share the wealth from a non-renewable resource with future generations of Alaskans. The Permanent Fund is there to help pay for the cost of government functions that Alaskans collectively demand, not to simply pay an inflated PFD.

Our governor and our legislators need to do a better job of explaining to people the facts regarding how the Permanent Fund grew to its present size, mainly due to both additional deposits by the legislature and that for the first 35 plus years the legislature did not withdraw their portion of the earnings but instead reinvested it. It makes no sense to me now that those excess monies should be paid out in the form of PFD checks while the State falls short of money to pay for the government that Alaskans collectively demand. My preference would be that we never have any form of a sales tax or an income tax so long as a PFD is still being distributed.

Protecting the Permanent Fund should be of utmost importance, and I am pleased that a few years ago the legislature passed a POMV statute to protect the Permanent Fund, although I believe the 5% draw limit should be reduced until the Permanent Fund reaches \$100 billion. If a constitutional amendment is necessary to protect the Permanent Fund, then I would support that. I am against any overdraw of the Permanent Fund and I am firmly against the proposed "bridge funding".

The PFD should not be constitutionally protected. Paying a PFD is not nearly as important as the many services that the State provides. The PFD does not have "First Call", it is one of numerous budget items and should compete against other government programs for prioritization and funding. Our Supreme Court has already determined that the PFD is subject to appropriation, thus any PFD amount paid is a full PFD. I do not feel that I am owed any back pay for historical reduced PFD's.

Governor Dunleavy decided to reduce the PFD to \$0.00 this year, I am satisfied with this PFD amount and believe that he should be credited with the \$0.00 2021 DUNLEAVY PFD.

The current PFD statute should be eliminated, and replaced with a statute that commits to attempting to pay a PFD as money allows. Perhaps a \$1,00 PFD cap should be included until the Permanent Fund reaches at least \$100 billion. While I believe that we should seek to receive the maximum compensation for our oil, I am not in favor of any income tax or sales tax to pay a larger PFD.

While I am against constitutionalizing the PFD, if this is pursued I believe that it should not be a 50/50 split. For the first 30 plus years the state has not used their portion of the 50/50 split, rather this money was left in the fund and continued to grow. My belief is that this non utilized money, as well as income from this money, should be subtracted from the Permanent Fund balance to determine an amount of money available for splitting.

I am of the belief that there are still minor savings to be found in the State budget, and that as these savings are found they should be implemented. I am not naive enough to believe that we can find enough savings to allow for paying what some Alaskans feel they are entitled to. There are some reductions that I would support that many others that I would not. The legislature was structured to balance the desires of the public, to provide the services that the citizens collectively desire, and to fund those services. I am satisfied with that balanced approach.

I believe that SB 53 is part of a balanced approach and I am in full support of this bill.
