### **Sponsor Statement**

# House Bill 273 (Version W)

February 7, 2022

"HB 273, An Act relating to education; increasing the base student allocation according to inflation; and providing for an effective date."

Years of flat funding in our schools has led to an effective financial loss for Alaska's students. While costs of everyday budget items have continued to increase, the amount the state is putting into schools has stayed the same. The base student allocation (BSA) in the foundation formula hasn't increased since FY17. Despite this, non-negotiable fixed costs have been steadily rising due to inflation. This puts downward pressure on our schools, forcing cuts to the classroom that ultimately come as a cost to our children, so districts can cover basic budget items like heat, sewer, electricity, and insurance.

We have a constitutional obligation to Alaska's families and economy to ensure strong schools. Yet, school funding continues to be unreliable. Alaska's school districts have had to depend on one-off funding bills afforded by the unreliable booms and busts of the oil and gas industry and outside funding to keep up with basic fixed costs. School boards and administrators have been forced to scramble with uncertain and increasingly underfunded budgets. Families worry about cuts to services and favorite teachers and staff. HB 273 offers a tempered and fair solution to keep education funding on track by ensuring that education's growth is directly tied to Alaska's growth.

U.S. Census data places Alaska 6th in the nation for education spending (state, federal, local). When adjusted for the cost of living index (COLI), Alaska's education spending is just below the U.S. average according to the Institute of Social and Economic Research (ISER). Looking more closely, Alaska has unique attributes that impact costs: smaller schools, (many located off the road system), the highest health care costs in the nation, and high energy costs.

HB 273 links the BSA directly to the Consumer Price Index for Urban Alaska over a three year rolling average. This would make it so money is no longer diverted from children and classrooms to cover the ever-growing fixed costs in school district's budgets. By averaging growth over multiple years of inflation, this bill also creates a steady and predictable budget that won't rise and fall when the market experiences drastic years of growth or loss.

This is a fundamental statewide economic issue. The best way to keep families and businesses, attract new residents, build a skilled workforce and maintain a strong economy is to assure good schools, pre-school through college. By ensuring a fair base to our schools' funding, we are investing in Alaska's future.

# Summary of Changes from Version I House Bill 273 (Version W)

February 7, 2022

"HB 273, An Act relating to education; increasing the base student allocation according to inflation; and providing for an effective date."

- 1. The document title is changed to highlight that inflation proofing intent of this bill.
- 2. The word "average" is added to line 6.
- 3. A lag year is added to the years used to calculate the applied inflation. This makes it so school administrators will know what their district's approximate allocation will be once the average daily membership is calculated in the fall, and will be able to sooner prepare the following year's budget.

**Section 1**. Amends AS 14.17.470, adding a new subsection that adds inflation proofing to the base student allocation in the foundation formula. The base student allocation would increase every year, based on the average inflation of the three-year previous Calendar Years, accounting for an additional lag year, of the Consumer Price Index of Urban Alaska, as measured by the United States Department of Labor, Bureau of Labor Statistics.

**Section 2.** Provides an effective date for the beginning of Fiscal Year 25 on July 1, 2024.

#### STATE OF ALASKA 2022 LEGISLATIVE SESSION

BILL NO. HB 273

#### **Analysis**

This bill amends AS 14.17.470 by having the department, on July 1 each year, increase the base student allocation (BSA) using the preceding three-year period of the Consumer Price Index for urban Alaska (CPI-U) as prepared by the United States Department of Labor. This fiscal note uses the Alaska annual CPI amount for 2020 (226.153) divided by the 2018 amount (225.545). (226.153/ 225.545 = 1.003) The percentage difference between 2020 and 2018 is applied to the current FY2023 BSA of \$5,930 to arrive at a CPI adjusted BSA of \$5,948. (\$5,930 x 1.003 = \$5,948) Using the FY2023 projected average daily membership counts, and the CPI adjusted BSA of \$5,948, the new estimated total state entitlement would increase by approximately \$4,612,362. The effective date of this bill is July 1, 2024 (FY2025). Page 3 of the PEF fiscal note provides the projected funding breakdown by school district for CPI-U Alaska BSA increase. The funding mechanism is a general fund transfer to the Public Education Fund (PEF). The fiscal note effect for FY2023 through FY2028 is reported in the fiscal note for the PEF, as the funding is deposited to the PEF, not into the Foundation Program funding component. The above analysis is presented here for explanation purposes only.

This bill amends AS 14.17.470 by having the department, on July 1 each year, increase the base student allocation (BSA) using the preceding three-year period of the Consumer Price Index for urban Alaska (CPI-U) as prepared by the United States Department of Labor.
This fiscal note uses the Alaska annual CPI amount for 2020 (226.153) divided by the 2018 amount (225.545).
