



#### Hello,

I was on the public testimony phone call today, and my name was called at about 5:15pm, and my phone taken off mute, but for some reason Sen Reinbold spoke for a second and then called on the next person.

Maybe it's a good thing, because I was going to make a lame joke and momentarily claim I was opposed to SB156! I was heartened to not hear a single person who was opposed to this bill. There is hope that the discrimination we, as medical freedom advocates, have endured will end. I FULLY SUPPORT SB156, as well as "more teeth" in the bill to retroactively hold accountable those sheep who enjoy a power trip in turning you away from medical treatment, businesses, etc, for not not vaccinating.
