- SB 156 would allow Alaska citizens to move about freely in society, regardless of their COVID-19 vaccination status. It would also prohibit harmful employer COVID-19 vaccine mandates.
- These mandates <u>lay the groundwork for discrimination</u> against individuals who are simply
  exercising personal discretion regarding their own medical choices. Often, these
  mandates <u>include penalties for employees</u> who choose not to comply, even if they do not pose
  any type of risk to their coworkers, customers, or other individuals.
- It is not unreasonable to implement certain common-sense health and safety policies in the workplace, such as directing employees to stay home if they are sick, or if they are exhibiting certain symptoms which indicate that coming to work would pose an unnecessary risk to themselves or someone else or that would prevent them from performing their duties. It is <u>unreasonable to penalize perfectly healthy individuals</u> who simply have not received a particular vaccine.
- A person's job is a necessity for him or her. Individuals who want and need to work <u>should not</u> <u>have to choose</u> between losing a job that provides for themselves and their families, or taking a vaccine they do not want or need.
- Our American system of government was founded upon protecting the rights of individuals. This protection entails prohibiting the intrusion upon these rights from other individuals and entities.
- Vaccine mandates are inappropriate, especially when the vaccine in question is already available to all who want it.
