I am writing in support of SB 156 and would like this testimony submitted to the record as a public testimony to the committee. I am a project manager who has served all of Alaska for the past 15 years, 10 of that in rural Alaska. I am originally from Eagle River and now reside in Palmer with my wife and children.

Before I begin, I would like to address one of the particularly silly responses I have heard from the Legislature and other government agencies: that somehow the Legislature does not want to pass a bill that "tells businesses what to do" This is the weakest response to this bill imaginable. The government tells businesses what they can and can't every day through ADA regulations, building codes, license requirements, and the other thousands of state regulations published on the State of Alaska website. The government already tells businesses not to discriminate against anything in Title 7 or the 1964 Civil Rights Act. This bill is merely an extension of the idea that people can not discriminate against another person. Medical segregation is no different than discrimination by race, religion, or another defining characteristic

To further emphasize that this is not a public health emergency, please find the attached report from Impact Research. A national research group dedicated to creating a narrative to unseat republicans. That's a direct quote from their website. <https://www.impactresearchinc.com/>

This document is the source of the recent pivot by liberal leaders and government agencies. The "public health" circus that we have endured for 2 years is now over. This is so the narrative can be flipped to:

1. Democrats "beat" covid. Zero Covid and forced vaccines have been the drumbeat for 9 months, not suddenly that doesn't poll well.
2. People are worn out. How is that a reason to end an emergency unless there never was one, to begin with?.
3. And my personal favorite: • Stop talking about restrictions and the unknown future ahead. If we focus on how bad things still are and how much worse they could get, we set Democrats up as failures unable to navigate us through this. When 99% of Americans can get vaccinated, we cause more harm than we prevent with voters by going into our third year talking about restrictions. And, if Democrats continue to hold a the posture that prioritizes COVID precautions over learning how to live in a world where COVID exists but does not dominate, they risk paying dearly for it in November.

Example #001 ADA

The ADA prohibits discrimination based on disability in employment, State and local government, public accommodations, commercial facilities, transportation, and telecommunications. It also applies to the United States Congress

To be protected by the ADA, one must have a disability or have a relationship or association with an individual with a disability. An individual with a disability is defined by the ADA as a person who has a physical or mental impairment that substantially limits one or more major life activities, a person who has a history or

record of such an impairment, or a person who is perceived by others as having such an impairment. The ADA does not specifically name all of the impairments that are covered

Title I requires employers with 15 or more employees to provide qualified individuals with disabilities an equal opportunity to benefit from the full range of employment-related opportunities available to others. For example, it prohibits discrimination in recruitment, hiring, promotions, training, pay, social activities, and other privileges of employment. It restricts questions that can be asked about an applicant's disability before a job offer is made, and it requires that employers make reasonable accommodation to the known physical or mental limitations of otherwise qualified individuals with disabilities, unless it results in an undue hardship. Religious entities with 15 or more employees are covered under title I.

So from ADA laws, a business may not restrict privileges of employment and make reasonable accommodations. Being unvaccinated is not an undue hardship on a business unless the government has forced you to lockdown.

Example #002 - Civil Rights Title 7

It shall be an unlawful employment practice for an employer -

- (1) to fail or refuse to hire or to discharge any individual, or otherwise to discriminate against any individual concerning his compensation, terms, conditions, or privileges of employment, because of such individual's race, color, religion, sex, or national origin; or
- (2) to limit, segregate, or classify his employees or applicants for employment in any way which would deprive or tend to deprive any individual of employment opportunities or otherwise adversely affect his status as an employee, because of such individual's race, color, religion, sex, or national origin.

Not sure how much clearer anyone can be on this. The law already states, no business can create a situation to deprive an individual of employment or adversely affect his status as an employee.

Example #003 HIPPA

The HIPAA Privacy Rule establishes national standards to protect individuals' medical records and other individually identifiable health information (collectively defined as "protected health information") and applies to health plans, health care clearinghouses, and those health care providers that conduct certain health care transactions electronically. The Rule requires appropriate safeguards to protect the privacy of protected health information and sets limits and conditions on the uses and disclosures that may be made of such information without an individual's authorization. The Rule also gives individuals rights over their protected health information, including rights to examine and obtain a copy of their health records, to direct a covered entity to transmit to a third party an electronic copy of their protected health information in an electronic health record, and to request corrections

As a direct result of this pandemic, our livelihoods have been threatened every day since the experimental vaccination began being administered. Both of our employers have stated that we may be subject to disciplinary action, or in the case of my wife terminated despite our deeply held religious beliefs and documented medical exemptions. In addition, our entire family survived COVID Exposure in 2020 but are not allowed to cite natural immunity. This one size fits all medical approach is unscientific, discriminatory in nature, and at best unethical. Vaccines are proven dangerous and ineffective as demonstrated by my daughter's reaction in 2019. She was given a well-child exam vaccine as part of the vaccine. She immediately went into uncontrolled vomiting, seizure, and spiked fevers for days. I was on-site in rural AK, with no way home to take care of my family due to a medically induced life-threatening event. Our doctor spend 6 months denying the reaction, and finally when pressed agreed that it was most likely the vaccine that cause the reaction, but didn't want us to have a negative opinion of vaccines.

After reading the insert of the vaccine, we learned the manufacturer stated her reaction was a known side effect, and she should not receive any vaccines if the reaction occurred. When we approached our doctor on this issue, we were hastily thrown out of the practice as anti-VAXes. We were not even allowed to question the vaccine. The law provides for exemptions, but medical professionals, businesses, and governments are allowed to discriminate against a population for a purely political and partisan issue.

More recently, I have been threatened with my job and way to provide for my family and under constant scrutiny from employers and potential clients as to my current status. These entities take State and Federal funds and claim they do not have to comply with Civil Rights Acts or Title 7 anti-discrimination laws. Vaccinated or not, no one should be allowed to discriminate against a personal choice that has no effect on anyone but themselves. The Vaccine has been proven, federally admitted to, and ignored by global media to NOT prevent transmission. The fact that a vaccinated person can spread Covid at the same rate as a vaccinated person means no passport, mandate, or another form of proof will keep our population safe.

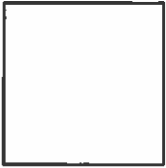
Dear Senators,

With this reality, vaccination mandates go into the trash can.

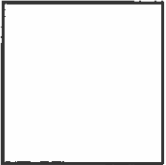

Good Morning All -

I am writing in support of SB 156 and would like this testimony submitted to the record. I am a project manager who has served all of Alaska for the past 15 years, 10 of that in rural Alaska. I am originally from Eagle River and now reside in Palmer with my wife and children.

As a direct result of this pandemic, our livelihoods have been threatened every day since the experimental vaccination began being administered. Both of our employers have stated that we may be subject to disciplinary action, or in the case of my wife actually terminated despite our deeply held religious beliefs and documented medical exemptions. In addition, our entire family survived COVID Exposure in 2020 but are not allowed to cite natural immunity. This one size fits all medical approach is unscientific, discriminatory in nature and at best unethical. Vaccines are proven dangerous

and ineffective as demonstrated by my daughters reaction in 2019. She was given a well child exam vaccine as part of the vaccine schedule, and immediately went into uncontrolled vomiting, seizure and spiked fevers for days. I was on site in rural AK, with no way home to take care of my family due to a medically induced life threatening event. Our doctor spend 6 months denying the reaction, and finally when pressed agreed that it was most likely the vaccine that cause the reaction, but didn't want us to have a negative opinion of vaccines.

After reading the insert of the vaccine, we learned the manufacture stated her reaction was known side affect, and she should not receive any vaccines if the reaction occurred. When we approached our doctor on this issues, we were hastily thrown out of the practice as anti-VAXes. We were not even allowed to question the vaccine. The law provides for exemptions, but medical professionals, business and government is allowed to discriminate against a population for a purely political and partisan issue.

More recently, i have been threatened with my job and way to provide for my family and under constant scrutiny from employers and potential clients as to my current status. These entities take State and Federal funds and claim they do not have to comply with Civil Rights Acts or Title 7 anti discrimination laws. Vaccinated or not, no one should be allowed to discriminate against a personal choice that has no affect on anyone but themselves. The Vaccine has been proven, federally admitted to, and ignored by global media to NOT prevent transmission. The fact that a vaccinated person can spread Covid at the same rate as a vaccinated person means no passport, mandate or other form of proof will keep our population safe.

I expect your full support for this Bill to move on trough the committee process and become law. The world is opening back up and reducing all restrictions and you should be a leader in ending medical tyranny, government overreach, and legalized segregation.

Alaska is a free state. if we do not fight now, our children will not have the opportunity to fight in the future.

Senator Reinbold,

Today I listened to the discussion surrounding SB156 and I support you whole-heartedly.

I am a health care provider, Registered Dietitian, in Palmer. I was fired for not receiving the vaccine from Norton Sound Health Corporation for which I worked nearly 7 years though I was breastfeeding. You might be aware that several infants have died as a result of the mothers vaccination through breast milk exposure. I am now working part time for Petersburg Medical Center, completely remote and they have harassed me and rejected my first letter for Religious Exemption. I submitted a legal letter with citations and they rejected that and wanted me to fill out their specific form to include signing that "I acknowledge by not getting the vaccination I am potentially life threatening to my family, community, patients, and coworkers. I have witnessed vaccine injury in the acute care. I will likely get fired as they have not told me whether they accepted my religious exemption appeal and have said they may ask for verifying documents.

Might I suggest if you add anything to this bill regarding private businesses, you could add language that any injury that is included as a potential risk of any of the vaccines (stroke, myocarditis, heart attack, GBS, neurological damage, etc) if the business forces vaccination as a term of employment they are liable for any medical costs for any of those health

issues following the vaccination. Do not write that they have to be proven to be associated with the vaccine since no physician will verify that. In clinical trials the rule prior to 2020 was that every death or event must be presumed a result of the vaccination. Presumption of injury is important in this case. As of right now the only medical exemption accepted is an anaphylactic reaction to a covid 19 vaccination. Meaning there are no medical exemptions.

I am one of many providers that have been fired from hospitals, the Governor felt that paying health care providers for the lower 48 to come up was a prudent use of our taxpayer money rather than employing the people who are already Alaskan providers licensed in the state. It is an absolute slap in my face. I have built a life here, served my community in health care and community service. I am raising my family here and paying taxes. I have not broken any laws and yet I am treated like a dangerous criminal based on my vaccination status. I worked through the entire pandemic when many providers quit or refused to go into the hospitals.

A last note that I think will provide an important perspective for you in this bill if you bear with me. My daughter had severe reactions to vaccination her entire life culminating in a life threatening reaction to her 4 year old vaccinations. We spent months in and out of doctors offices, doing all sorts of treatments and tests when finally, the pediatrician who has given my daughter all of her vaccines and held her the day she was born, admitted it was likely a very rare and severe reaction to the vaccine. When I asked her why she didn't tell us that the first day, she responded "I didn't want you to become anti-vax because of a rare event". I asked if her previous extremely high fevers over (105), breathing problems, projectile vomiting and numerous other frightening symptoms that forced us to move out of Nome to be able to be closer to a big hospital for her health, was a result of her intolerance to the vaccine or ingredients, she replied "likely, yes". When I asked for the inserts, she said "there's nothing in there for you, it's all complicated clinical data". I finally convinced her to give me the inserts and it clearly stated that if these specific events my daughter had as an infant occurred she should not receive any other vaccinations for risk of life threatening events and death. The insert also said it is likely genetic and can present in siblings. I then asked the same pediatrician if she would write a medical exemption for my daughter considering the insert specifically stated not to receive more vaccination. She told me "No and if you do not wish to vaccinate your children now we won't be able to keep them in our practice". I cannot get a medical exemption from covid 19 vaccination although she has an exemption from the rest of childhood vaccinations.

Exemptions have not ever worked the way they were intended. Our pediatrician knew our daughter was having bad reactions to vaccination and continued to push vaccination to the point of her life threatening event. I see now many physicians have denied writing exemptions for patients who have serious blood clotting issues, previous extreme reactions to vaccination, previous GBS among many other diagnoses contraindicated to these specific vaccinations. We must protect individual rights and sovereignty. There are no consequences for any of the businesses, doctors or government when there are reactions and private businesses are actively and aggressively denying honest exemptions. We have nothing if we do not have our bodies.

I am praying for you and will be following this closely.

If you have the time and ability could you point me to where to find the "opt in state medical devices and services" laws you mentioned. I would like to provide those to a number of parents who are fighting the school districts around the state.


