The Department of Education & Early Development's (DEED's) standard cost for all fiscal notes that require any regulations work is a one-time increment of \$6,000. The regulations process involves Department of Law working on behalf of DEED to prepare the necessary legal regulation changes to go before the State Board of Education & Early Development or the Alaska State Council on the Arts. There over 70 education related bills currently introduced that impact DEED. If multiple bills pass through the legislature and require regulations changes, this would result in thousands of dollars of required legal work with no associated funding in budget.
