Dear Senator Reinbold,

As an Alaskan citizen I thank you for sponsoring SB 156 that would make vaccine mandates and so-called "immunity passports" unlawful in Alaska. No one should be fired from their job, kicked out of school, or denied access to public spaces for simply declining to accept a medical intervention. Especially an intervention that the CDC itself states does not prevent infection or transmission. It has been proven natural immunity is far superior (without the risk of adverse reactions) then an experimental vaccine that requires many boosters and risks, including damaging the immune system and bodily organs amongst many other possible negative effects, including death.

The Nuremberg Code, as well as federal law, provide that no human being can be forced to participate in a medical experiment. Under 21 U.S. Code Sec.360bbb-3(e)(1)(A)(ii)(III), "authorization for medical products for use in emergencies," it is unlawful to deny someone a job or an education because they refuse to be an experimental subject. 21 U.S. Code § 360bbb-3 - Authorization for medical products for use in emergencies Federal Food, Drug, and Cosmetic Act that authorizes the FDA to grant emergency use authorization also requires the secretary of Health and Human Services to "ensure that individuals to whom the product is administered are informed ... of the option to accept or refuse administration of the product." This is also made clear in the FDA fact sheet provided to patients receiving any COVID-19 vaccine. It states: "Under the EUA, it is your choice to receive or not receive the vaccine. Should you decide not to receive it, it will not change your standard medical care."

However, U.S. law does allow employers and schools to require students and workers to take fully licensed vaccines.

EUA products can't be used once fully licensed product becomes available. Individuals must have the right to accept or refuse administration of any EUA product, I SUPPORT SB 156, to protect medical freedom in Alaska, please vote yes to make vaccine mandates and so-called "immunity passports" unlawful in Alaska.
