To Whom it May Concern,

I strongly support Bill SB 15. The ability to choose what medications one takes is a fundamental human right. Making someone choose between their livelihood or taking an experimental medication is coercive and unethical. A person who has adverse side effects from the shots has no legal recourse to sue. All risk and liability falls to the individual. What is happening across the country with vaccine mandates is an abuse of power. This fundamental freedom must be protected. WRITTEN TESTIMONY TO HEALTH AND SOCIAL SERVICESUPPORT OF SB 156

Chair and Committee of Health and Social Services:

My name is Christopher Wagar, I'm a retired school teacher who taught in Anchorage for 28 years.

I would like to thank Senator Reinbold for her sponsorship of this bill and thank the Chair and Committee for listening to testimony. Additionally, thank you to all the amazing professionals who shared their knowledge and expertise in the testimony that followed the initial presentation.

Even before listening to testimony, off the top of my head, I had written the names of what should be well known Doctors, whom I believe have worked diligently to advocate for Truth over Fear. Dr. Bob Malone (patent holder of MRNA technology), Dr. Judy Mitkovitz, Dr. Peter McCollough, Dr. Ryan Cole, Dr. Vladimir Zelenko, Dr. David Martin and Dr. Michael Yeadon to name a few. Also, Alaska's own Dr. John Nolte, Dr. Miriam Nolte as well as Dr. Ilona Farr, who have had their medical credentials threatened because they are advocates of early treatment methods which are counter to the "shot" narrative. Senate HHS Committee Members,

My name is Brittany Lauper, I live in Anchorage. I am writing to ask you to hear my concerns and to state that I fully support the proposed Senate Bill 156 to protect our God given rights to bodily autonomy.

In 2013, at age 27, I was diagnosed with a genetic disorder called Lynch Syndrome which causes my genes to mutate and attack my body and caused me to develop Colorectal cancer; by God's grace he healed me from that. Lynch Syndrome also gives me a much higher possibility of developing other cancers and unfortunately, I haven't been unable to get my yearly preventative exams due to the unreasonable requirements of the Doctor's offices & Surgery Centers i.e., being forced to suffocate with a mask and swabbing my nose with toxic chemicals.

I haven't been able to get any answers from my Genetic Counselor regarding safety and/or effects of this new drug on Lynch Syndrome, but in December I finally met with my Colorectal doctor (whom I had previously greatly respected) to see if she would be willing to sign a medical exemption for my employer (although I had a religious exemption letter prepared as well, I felt I qualified for both). After sitting down with my Doctor going through all my questions & notes I brought with me, all she could say was "it's safe and effective" ... No elaboration on how it could affect someone with Lynch Syndrome and DNA disorder. When I respectfully asked her "is this your medical opinion that it's safe for me and my personal medical history? Or is this your personal ethical opinion because you think I should get it?" And she said it's her personal ethical opinion and she believes everyone should get it... then adding "You could probably find an anti-vax doctor in town that would sign your medical exemption." This is medical malpractice.

The audacity of a government thinking they can force something into my body and implement a blanket mandate over every human with NO regard to personal medical circumstances or religious beliefs is not only unconstitutional, but an egregious human rights violation.

Additionally, to require us to jump through stressful, time consuming & financially costly hoops to get a medical or religious exemption - that has been shown to likely be denied by most employers - only to put us on a government list to keep track of the exemptions that are accepted, makes me feel like less of a human.

The stress and anxiety caused from the threats of losing our ability to make an income is an awful feeling. This is NOT about my health. This is NOT about my safety. This is about the federal government being able to persecute us and control our lives - indefinitely. This is not right... Something very, very bad is happening here.

This medical experiment they are coercing many confused & fearful people to a part of is nothing less than criminal. There is no informed consent. I know you have seen the unbelievable numbers of deaths and injuries caused from this experiment. I do not understand how anyone is still pretending like this is any kind of cure for getting back to our normal free lives. Anyone who is injected can get this illness and still spread it. It's completely illogical.

It is YOUR DUTY to secure & protect our rights. Emergency power is NOT a governing power in our state. We need to hear more of our state leaders taking a bold stand and speaking up about the dangers of this shot. If we the "little people" are aware of the data - you must be aware too. Being willfully ignorant will not be acceptable when this is exposed for what it is. I will not accept this as "safe and effective". It is a lie. There is no evidence this is safe OR effective. There are no successful safety studies. It is dangerous and it is killing people. This injection is the most toxic in US history - and it's only been 1 year - and our lives are being threatened with it. You are our Representatives for the main purpose of keeping our inalienable rights safe & sacred. PLEASE support this crucial bill.

Liberty is not dead; it is a living, vibrant, powerful force and it will not be taken from me.

So, I fully support SB 156, Covid-19 Vaccine Discrimination and I only support our elected leaders that uphold their oath to protect our sovereignty of choice.
