The Alaska Federation of Natives (AFN) is the largest statewide Native organization in Alaska. Our membership includes 169 federally-recognized tribes, 166 village corporations, 10 regional corporations, and 12 regional nonprofit and tribal consortiums that contract and run federal programs.

AFN continues to be the principal forum and voice of Alaska Natives in addressing critical issues of public policy and government. Our mission is to enhance and promote the cultural, economic, and political voice of the entire Alaska Native community.



OUR BEGINNING


AFN was formed in October 1966, as 400 Alaska Natives representing 17 organizations gathered for a three day conference to address Alaska Native aboriginal land claims issues that arose after Alaska's statehood in 1958. AFN was instrumental in lobbying for the Alaska Native Claims Settlement Act (ANCSA), which was signed into law on December 18, 1971. ANCSA conveyed over 40 million acres of land and nearly \$1 billion dollars in compensation to Alaska Native peoples. After successfully passing ANCSA, AFN worked to ensure its successful implementation. Since the 1970's, AFN has turned our attention to economic, social, cultural, and legal issues arising in Native communities.

LEADERSHIP

AFN has a 38 member board that consists of 12 ANCSA regional corporation representatives, 12 regional Native non-profit representatives, and 12 tribal or village representatives elected at our annual convention.
