Hi Jasmine,

My apologies for not getting this to you sooner, or in an official letterhead response (which I can follow up with).

How long does it normally take to notify a guardian of a juvenile when a juvenile is in custody?

- While we strive to make notification as soon as possible, it depends on several factors, as each situation is unique unto itself and very, very dynamic:
 - o If the juvenile (J) is cooperative and willing to speak with us. Sometimes they are uncooperative and/or refuse to talk to the officer.
 - o If the parent / guardian (p/g) is home or present at the location of the investigation.
 - o If the officer is within cell range to make investigative / follow up phone calls.
 - If the investigation is taking place in a rural area (i.e., fish camp, out on a boat in the ocean, logging camp, etc., etc.), sometimes you have to wait until you get back to an area that has cell phone coverage or a hub community to reach out to resources.

How does public safety identify a juveniles guardian?

- We ask the juvenile (J) who their parent / guardian (p/g) is
- Where does the p/g work at
- What is the p/g telephone numbers work and cell
- What is the home address of the p/g
- Ask the J if they are aware of any court order stating who the p/g is
- We look in our records management system to see if there are any court orders showing who the p/g is
- We call the court and ask if there are court orders on file regarding p/g designation
- We call OCS (office of children's services to see if they know who the p/g is
- We look in APSIN our records management system for case history & person involvement history
- Contact DMV to see who signed a waiver for a juvenile to drive
- We ask neighbors of the J to see if they happen to know
- Sometimes we can do searches for those living at the same residence but that starts getting kind of difficult with our records management system where records can be incomplete (people don't tell us when they move).
- By asking the Division of Juvenile Justice to help with finding out who the p/g is
