My name is DENNY KAY WEATHERS, I live on Hawkins Island in Prince William Sound. For the record I strongly **oppose** HB 17.

I was born into a family with seven siblings (four boys and three girls), I am the mother of two adult male sons, the Grandmother of two Grandsons and two Granddaughters and two step-Grandchildren. I also am an Aunt to many nephews and nieces, Great and Great-Great of which out of all of us (approx. 113 and growing) only two have had gender issues (both are in their twenties). But with all families there are issues; there were a few in the family that were alcoholics, smokers, drug users and two ended up in prison for breaking the law but at no time did we ever turn our backs on any of them; no, a good Christian will try to help anyone in need but that person must be receptive to help first.

The problem is when the Government starts regulating the law by how a **certain group of people determine their "WILL"** (i.e. how they want to determine their own gender or wants to be identified as something different) it becomes a problem and rather than encourage their identity issues we should be helping them overcome them with loving kindness and truth.

Representatives,

I am writing to oppose HB 17 as it is currently written. I am a Christian, health care provider, and mother in Palmer Alaska.

While all people should be treated equally with dignity and respect I oppose legislation that forces a group of people to play pretend, to violate their religious liberty, and in some cases create dangerous situations for children.

We are likely all aware of the transgender girl (really a teenage male) in Fulton county who has raped and sodomized a young girl on school grounds using the women's restroom under a transgender equality policy to which the school administration and the school board then tried to cover up. While the public employees were covering up the incident, the same male student raped and sodomized more young women. He was charged in court at a minor for rape, assault and sodomy.

I have grave concerns about biological males who are suffering from gender dysmorphia as determined by the Academy of Pediatrics, being able to use women's facilities. I do not permit my very young daughter to be seen naked by men or boys nor do I want her exposed to male genitals at the rec center, the Alaska club, the school bathroom, etc.

When we pass legislation like this we force individuals to use certain speech. That's is a violation of our first amendment. We endanger young women and girls who will be exposed to the genitals on young men and boys which is a violation of their privacy and religious rights. It makes schools, lockerooms, sporting events, pools all unsafe for young girls.

If legislation like this is to be passed it must recognize that you cannot force someone to use certain pronouns or speech and no civil or criminal penalties can be brought against someone who for instance uses the wrong pronouns for an individual with gender dysmorphia. You cannot allow a transgender person to use the private facilities of the physical gender for which they are not. They can be given their own facilities or private individual facilities to use. But there should never be a male genital in a women's locker room or bathroom where women and girls are at their most vulnerable.

In a State with the HIGHEST rape, sex trafficking, and domestic abuse we cannot force women in vulnerable situations to come in contact with men. The trauma of forcing rape victims to use facilities with men in the most vulnerable situations they could be in is horrific. Their rights to privacy should not be suspended to accommodate males wishing to be female.

This bill must be seriously amended to reflect the balance of first amendment rights, privacy rights and religious rights of other individuals.

You cannot force someone to speak your pronouns or punish them for not saying them

correctly in civil court or otherwise. That violates freedom of speech.

You cannot use the same facilities in which women and girls are naked and vulnerable. Separate facilities are required for transgender or gender fluid individuals to not violate the privacy and religious rights of biological women. If men expose themselves to young girls or women intentionally that is punishable by law. Forcing rape victims to be nude with men in locker rooms or bathrooms is wrong.

I look forward to watching the testimony on this bill, I urge you to consider the first amendment rights and safety of all of the women and girls in Alaska when looking at bills like this, not just the gender confused.
