The Lions Club building is a building very critical to the residents of the community. It is the venue of annual free community Thanksgiving and Christmas dinners. The Boy Scout troop which is sponsored by the Lions routinely provide youthful volunteers for these holiday dinners. It is also a venue for celebrations; landmark anniversaries, weddings and memorials to say goodbye to friends and community pioneers.

The previous leases, especially the recent longer leases, have been adequate to this point, but unfortunately this option will not be available after 2024 because of a recent court decision. It would be a real tragedy if a half century of effective and efficient management by the Eagle River Lions was not allowed to continue.
