## Dear Representatives:

This letter presents responses to the House Health and Social Services Committee member questions received by the Department of Health and Social Services (DHSS) at the Thursday, March 17, 2022, hearing on HB 172 Mental Health Facilities & Meds.

### **Question Rep. Kurka:**

How many individuals are served on a Title 47 ex parte hold or commitment?

#### **DHSS Response:**

This question is more accurately answered by the Alaska Court System; however, Nancy Meade did provide the following: The count of the number of petitions filed for CYs 2018-2020 is roughly between 2100 and 2700 each of those three years; that number includes the 3-day, the 30-day, the 90-day, and the 180-day. The largest category by far is the three-day petition. The Alaska Court System will be available for questions during the March 22 hearing.

#### **Question Rep. McCarty:**

Will lab work be available to these facilities to determine if medications are effective and being taken?

## **DHSS Response:**

Lab work would be available for centers to send labs out on a voluntary basis. Blood work cannot be forced for an involuntary patient. Medication services provided through a crisis stabilization center or crisis residential and stabilization services includes medication prescription, review of medication, medication administration, and medication management. There are no restrictions preventing either service type from utilizing lab work to determine the effectiveness of medication.

### **Question Rep. Snyder:**

How frequently are crisis medications having to be utilized in crisis stabilization centers and crisis residential centers?

# **DHSS Response:**

We reached out to RI International to share statistics from their crisis stabilization center and crisis residential center in Peoria, Arizona. They report that generally less than 40 events per month require the intervention of crisis medication for the 500-550 admissions per month in the facilities. On the high end that is about 8%.
