A BILL

FOR AN ACT ENTITLED

- 1 "An Act relating to concurrent vocational education, training, and on-the-job trade
- 2 experience programs for students enrolled in public secondary schools; relating to child
- 3 labor; and providing for an effective date."

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

5 * Section 1. AS 12.62.400(a) is amended to read:

6 (a) To obtain a national criminal history record check for determining a 7 person's qualifications for a license, permit, registration, employment, or position, a 8 person shall submit the person's fingerprints to the department with the fee established 9 by AS 12.62.160. The department may submit the fingerprints to the Federal Bureau 10 of Investigation to obtain a national criminal history record check of the person for the 11 purpose of evaluating a person's qualifications for

(1) a license or conditional contractor's permit to manufacture, sell,
offer for sale, possess for sale or barter, traffic in, or barter an alcoholic beverage
under AS 04.11;

21	(a) The department shall
22	(1) exercise general supervision over the public schools of the state
23	except the University of Alaska;
24	(2) study the conditions and needs of the public schools of the state,
25	adopt or recommend plans, administer and evaluate grants to improve school
26	performance awarded under AS 14.03.125, and adopt regulations for the improvement
27	of the public schools; the department may consult with the University of Alaska to
28	develop secondary education requirements to improve student achievement in college
29	preparatory courses;
30	(3) provide advisory and consultative services to all public school
31	governing bodies and personnel;

(4) prescribe by regulation a minimum course of study for the public schools; the regulations must provide that, if a course in American Sign Language is given, the course shall be given credit as a course in a foreign language;

(5) establish, in coordination with the Department of Health and Social Services, a program for the continuing education of children who are held in detention facilities in the state during the period of detention;

(6) accredit those public schools that meet accreditation standards

session, and become effective 45 days after presentation or at the end of the session,
whichever is earlier, unless disapproved by a resolution concurred in by a majority of
the members of each house;

13 (7) prescribe by regulation, after consultation with the state fire 14 marshal and the state sanitarian, standards that will ensure healthful and safe 15 conditions in the public and private schools of the state, including a requirement of 16 physical examinations and immunizations in pre-elementary schools; the standards for 17 private schools may not be more stringent than those for public schools;

18 (8) exercise general supervision over pre-elementary schools that
19 receive direct state or federal funding;

(9) exercise general supervision over elementary and secondary
 correspondence study programs offered by municipal school districts or regional

5	Sec. 14.35.100. State policy. It is the policy of this state to provide public
6	secondary school students over 14 years of age the opportunity to participate in
7	concurrent vocational education, training, and on-the-job trade experience programs
8	from nonsectarian agencies providing industry-standard instruction.
9	Sec. 14.35.105. Program contracts. (a) The department shall negotiate
10	contracts with agencies providing industry-standard instruction and certifications to
11	offer concurrent vocational education, training, and on-the-job trade experience
12	programs for students enrolled in a public secondary school.
13	(b) The department may establish minimum program eligibility standards.
14	(c) The department may not contract with a sectarian agency.
15	(d) A contract entered into under this section must include
16	(1) a description of the program, including the program curriculum and
17	the public purpose that the program supports;
18	(2) the number of eligible students over 14 years of age who may
19	participate in the program each year;
20	(3) the annual tuition for each student for program participation;
21	(4) the name and proof of industry-standard certification of each

Sec. 14.35.110. Program list. (a) The department shall annually compile, provide to school districts, and publish on the department's Internet website a list of concurrent vocational education, training, and on-the-job trade experience programs that the department contracts with to provide concurrent vocational education.

(b) For each listed program, the department shall identify any geographic attendance restrictions, program availability, and the districts that may participate in the program.

15 Sec. 14.35.115. Student enrollment. (a) The department shall enroll in a 16 contracted concurrent vocational education, training, or on-the-job trade experience 17 program a student over 14 years of age who is enrolled in a public secondary school 18 eligible for the program and who submits a timely application. If the number of 19 applications for a program exceeds the capacity of the program or age group, the 20 department shall select students by random drawing.

(b) A secondary school shall pay the program tuition for an enrolled student
who participates in a contracted concurrent vocational education program in
accordance with the terms of the contract entered into under AS 14.35.105.

Sec. 14.35.120. Individual learning plan. (a) For each student enrolled in a public secondary school who participates in a contracted concurrent vocational program, the secondary school shall annually provide an individual learning plan developed in collaboration with the student, the parent or guardian of the student, a school counselor assigned to the student, and other individuals involved in the student's learning plan.

(b) An individual learning plan must

(1) be developed with input from the counselor assigned to the student;

1 (2) provide for an in-school and concurrent vocational education 2 program course of study appropriate for the student's age and grade level consistent 3 with state and district standards;

(3) provide for an ongoing assessment plan that includes industrystandard certification progress and statewide assessments required for public schools under AS 14.03.123(f); and

7 (4) provide for monitoring of the student's work and certification
8 progress by the counselor assigned to the student.

9 Sec. 14.35.125. Instructor certification. (a) A person may not instruct 10 students in a concurrent vocational education, training, or on-the-job trade experience 11 program unless the person possesses a valid instructor certificate and an industry-12 standard master skill certification or equivalent.

(b) The board shall establish requirements for the issuance of instructorcertificates by regulation.

15 (c) The board shall require instructors to submit fingerprints and the fees 16 required by the Department of Public Safety under AS 12.62.160 for criminal justice 17 information and a national criminal history record check. The board shall submit the 18 fingerprints and fees to the Department of Public Safety for a report of criminal justice 19 information under AS 12.62 and a national criminal history record check under 20 AS 12.62.400.

(d) The department may not issue an instructor certificate to a person who has
been convicted of a crime, or an attempt, solicitation, or conspiracy to commit a crime,
involving a minor under AS 11.41.410 - 11.41.460 or a law or ordinance in another
jurisdiction with elements similar to an offense described in this subsection.

(a) A minor under 16 years of age may not be employed for more than a
combined total of nine hours school attendance and employment in one day. If
employed, the minor's work may be performed only between 5 a.m. and <u>10 p.m.</u> [9
P.M.] Employment outside school hours may not exceed 23 hours in one week,
domestic work and baby-sitting excepted.
