Dear Legislators:

HB 203 encourages responsible gun ownership and will help stop countless preventable premature deaths.

My closest friend in Juneau lost her son to a gun accident just before his 15th birthday over 10 years ago. She will never fully recover from this tragedy. It was a hideous situation with teenage boys being cajoled by a bully to play "Russian roulette." The shooter's dad was ex military and should have known how to keep firearms safely. But without legal consequences, apparently, people get careless. This is not working for our children. Firearms are the first-leading cause of death among children and teens in the state, with an average of 22 firearm deaths every year. Nearly 60 percent of those deaths are firearm suicides.

In Alaska, there is currently no requirement that gun owners secure their firearms whereas our great state has the second highest rate of gun deaths in the country.

Millions of responsible gun owners do follow recommended secure storage practices, but it's estimated that more than half of gun owners do not lock all of their guns, let alone store them unloaded, locked, and separate from ammunition as experts recommend.

A 2019 study estimated that if half of households with children that contain at least one unlocked gun switched to locking all their guns, one-third of youth gun suicides and unintentional deaths could be prevented – saving an estimated 251 lives in a single year.

Every year, 173 people die by guns in Alaska and another 332 people are wounded by guns. Alaska has the 3rd-highest rate of gun suicide deaths in the US, and the highest rate of gun suicide deaths among young people. These statistics are unacceptable because they are not just numbers. They represent our youth, and our future. We must, and we can, do better.

Please pass HB 203 out of your committee unanimously.

To the Honorable Chair and Committee Members:

I am Marian Clough, residing in Auke Bay, Alaska, testifying in support of HB203 as a citizen, a parent, a grandma, and as a member of Alaska's Chapter of Moms' Demand Action.

Gun owners in Alaska can make their homes safer by storing their guns securely — which means <u>storing guns</u> <u>locked</u> so children and teenagers cannot access them. Secure storage of guns can prevent unintentional shootings, where a child gets hold of a gun and shoots themselves or someone else.

Currently in Alaska we have no requirement to lock up our firearms when they are not in use. Alaska has the highest rate of gun deaths in the nation. Firearms are the number one cause of death among children and teens in our state, with an average of 22 Alaskan children and teens killed by a gun each year.

HB203, the Alaska Secure Storage of Firearms Act, is a bi-partisan bill with both Republican and Democrat cosponsors. These legislators recognize that this is a safety issue -- securing our firearms to prevent an unintentional shooting. Having firearms in Alaska is part of our culture; adding a safety measure to prevent an unintentional shooting makes sense to protect our loved ones.

As a parent, a grandparent and an Alaskan, I truly believe this legislation would help to provide a safer environment for the children and teens in our great state.

In addition, I respectfully request that the House State Affairs Committee schedule a public hearing so Alaskans such as myself can speak to you directly about this life-saving bill.

Support HB203 Alaska Safe Storage of Firearms Act

Dear Chairman and Committee Members:

A Safe Storage Act is so important. Alaskans are too casual with their guns. Our community has been marked by gun tragedies for as long as I have lived here. I moved to Sitka over 40 years ago and worked more than 20 years for the State. This employment was book-ended by two gun tragedies: On my first month of work the young son of one of my coworkers was killed in a game of Russian Roulette. In 2009, a colleague lost his teenage son to suicide by gun. Both of these were tragic, unexpected and shocking events that continue to reverberate. In Sitka in October 2020, a near-tragedy occurred when a 4-year-old was playing with an unsecured loaded AK-47 and fired multiple shots through the wall of the trailer into a trailer park while his father was asleep. I now have 2 young granddaughters and I think about the chances of a gun related accident occurring in home daycare situations or while they may be playing at a friends or relative's house. This terrifies me. Guns are the first-leading cause of death among children and teens in Alaska.

In 2019 the Alaska Division of Public Health found that nearly 50% of Alaska high school students have access to a loaded gun and one in four high school students said they had seriously considered suicide in the last 12 months. After these 2+ pandemic years it isn't too hard to imagine that even greater numbers of teens have considered suicide.

A Secure Storage law would help to save the lives of children and teens by reducing access to loaded guns, directly reducing accidents and suicides. I support this bill and hope you all will pass it. My husband and I own many guns and believe strongly in the owner responsibility for safe storage. The strength of the data should secure your vote for this bill, if not please hold a public hearing and allow the public to testify – I believe you will find overwhelming support for this common sense regulation.
