Dear House State Affairs Committee:

Please pass SB156 either in the form it was received from the Senate, or in a form that enhances its intent. In your consideration of SB156, please consider the vaccine discrimination presently occurring in New York City.

Athletes and performers in NYC are exempt from vaccination requirements, while the common citizen and employee are not. Many unvaccinated employees have been fired, and more are likely to follow.

Exempted athletes and performers most commonly cited in news stories are highly paid professional athletes. In light of vaccine mandates for non-athletes, the exception carries a connotation of unfair economic privilege; something that rallies and ignites socialists' reactions. In practice, however, what NYC truly has is not a case of economic privilege based vaccine discrimination, but instead, vaccine discrimination based on the cultural value of artists to the political agenda of NYC politicians.

Not all performers are highly paid athletes. Performers could include ballet dancers, comedians, tribute bands, mimes, and ventriloquists. Performing, including athletic performance by highly paid athletes, is an art form. Instead of highly paid athletes, we should recognize the exempted athletes and performers collectively as artists.

Lifting restrictions on artists has the effect of securing widespread conformance among NYC's general population with NYC mandates. Making an individual decision to not participate in the art and culture of New York City equates to an act of self-ostracization, and ultimately – in many cases – financial ruin.

Art is not socioeconomically stratified. In the specific case recently cited by Fox & Friends Weekend of a fired food service worker at Yankee Stadium, the artform in question (Yankees baseball; perhaps the most popular and most valued artform in NYC) is fully integrated throughout NYC culture across all socioeconomic aspects and levels. Art is culture. Much like a gladiator event at the Roman Colosseum was for the Romans, New York Yankee baseball is perhaps the most prominent expression of the art and culture of New York City. It is clear, therefore, that the entanglement of mandates and exemptions with athletes and performers makes art and the art industry the preferred agent of cultural transformation for New York City.

For the Mayor of New York City, vaccine exemptions fuel his political base with the social friction it is built upon which further empowers him. It also enables the desired cultural change; the financial ruin and cultural ostracism of the unvaccinated, and the compliance of those who have no other alternative. This yields a political cleansing of individuals from NYC who are either unsupportive or noncompliant. Achieving this objective is largely made possible by preserving the ability of artists to continue functioning with minimal impact from the very mandate and commandeered authority NYC intends to entrench as a new cultural norm.

While it is already clear to me that the vaccine mandates too many have already suffered from are unsavory, should a bill like SB156 not become law soon, what could that mean for Alaska and Alaskans in the future? Can you completely rule out the possibility of a current or future scenario where, as is occurring in New York City, a political party and favored industry exploits public health authority to effect dramatic cultural change in Alaska?

To insulate and protect Alaskans from the kind of disturbing health and cultural manipulation occurring in New York City, please pass SB156.

My wife was forced out of her job and now with the CMS mandate will never be allowed to work in her field again, never be able to use her degree or earn as much income. This mandate has negated her Master's in Dietetics.

As for myself, now the sole income for our house of 5, with three kids under 7, my job is threatened every day by these mandates. I have taken to working additional hours and even taken a second job to secure additional income and potentially replace my income should the worst happen.

As a project manager in Alaska for the past decade, I can tell you these mandates are absolutely reducing the number of quality workers looking to fill jobs in Alaska. We have less applicants every day when they see any requirements for vaccines.

Again, i urge you to not hide behind procedure or delay tactics. Bring this bill to the committee and witness the overwhelming support you will get from the people calling in to support this bill.

If we do not have the individual right to decide what we can put in our bodies, we have no rights at all and the leaders of the emergency can use force against the people legally. This is not a sterilizing vaccine.

As a survivor of Covid and the "winter of death and despair," we know now that the unvaccinated pose no more risk than the vaccinated.

Subject: My Testimony on SB 156

I also write in support of SB 156. It's a shame that there needs to be a law like this even introduced in order to reinforce our already existing freedom from medical and religious tyranny. We shouldn't be living of such threats and in fear like we have for the last 2 years with our freedoms being threatened, restricted, and suspended. Never in my life did I think I would see experience this in America. If I had known my country would do this to its people, I never would have signed up to defend her after 9-11. I write in support of SB 156, both as an individual and as Associate Chief Medical Officer of America's Frontline Doctors. In fact, I further encourage that the act be strengthened to proscribe any person, governmental entity or employer to enquire as to vaccine status or to keep records of the same, except in the keeping of medical records by the individual's chosen providers.

The reality is that all vaccines, including those I would willingly give my own child, affect only the health of the vaccinated. No vaccine is superior to natural immunity in reducing transmission or providing immunity. Vaccines have never contributed to the eradication of any pathogen with animal reservoirs, which every pathogen except Variola (smallpox) has. Therefore, there is no governmental interest in in forced or coerced vaccination. Vaccination is an immune system manipulation that any individual may consider, but it will have no effect on the disease risk of another individual.

Nor can an argument against SB 156 be based on the Biden administration's mandate for Medicare/Medicaid billing. While the Supreme Court of the United States has chosen not to enjoin such a mandate, it is still in trial with no final decision. It should be noted that no FDA approved vaccine for COVID-19 is available in the United States at present. While Comirnaty has been approved, it is not available in the US. Therefor no available COVID-19 vaccine in the US can be required as all are experimental, and no one can be forced to consent to experimental treatment under federal law. Further, while said mandate prevents submitting bills to Medicare/Medicaid from unvaccinated providers, it does not prevent any provider from delivering and charging for care. Employers can comply with SB 156 simply by charging patients directly for their services. The Federal government will then have the choice between ending its mandate, or making Medicare/Medicaid useless in Alaska. In short, SB 156 would simply make all employers and healthcare providers into a large bargaining block against the federal government's unconstitutional mandate. In fact, it is this financial coercion of this mandate that requires a "don't ask, don't keep records" amendment to SB 156, so that no employer or governmental entity can use vaccine status to discriminate on specious grounds.

SB 156 stands on the firmest ground, both for medical, biological and constitutional reasons.

Dear Representatives Kreiss-Thomkins and Claman,

Please schedule SB156 for hearing before the House State Affairs Committee.

It is important that Alaska law affirm the right of people to freely choose whether or not to take a Covid vaccine.

It is a personal medical decision that should only be decided by personal informed consent, and not be forced, coerced, or influenced by any employer, public administrator, or private entity.

The data now show that the protection of the Covid vaccines is personal and it wanes with time; it can reduce in the odds of becoming severely ill, but does not prevent one from catching and spreading the virus, or in fact, still being hospitalized with Covid.

Additionally, as the Covid virus has mutated the vaccines have become increasingly less effective against the new variants, as in the case of the Omicron variant against which the vaccines are less than 20% effective. Honorable Alaskan lawmaker,

As presently written, I agree completely with SB 156, which is presently before the House State Affairs committee. This bill, which received bi-partisan support in the Senate, should also be enacted by the House, in a timely manner.

By federal law, everyone is supposed to have the right to "informed consent" before receiving any vaccine or medication. Vaccine mandates, for any reason, deny this right, in violation of national and international law, including the Nuremberg Codes.

There is insufficient data concerning the COVID-19 mRNA vaccines for anyone to be properly "informed." The technology is new, but has a troubling developmental history. Trials were several years shorter than required for previous vaccines. The vaccine manufacturers and federal medical oversight agencies have not been forthcoming with pertinent data. However, by court order, Pfizer has recently begun to release the data by which the FDA granted Emergency Use Authorization. From what has been released thus far, it is evident that despite an alarming number of severe adverse events, observed early in the process, EUA was granted to a product that was far from safe.

From the beginning of the public vaccine roll-out, serious side-effects, including permanent disability and death have been reported to the VAERS. The government agencies, charged with analyzing adverse events and ensuring pharmaceutical safety, have largely ignored that data. (Now that the Pfizer data is being made public, we can see that they chose to ignore the severe risks, of which they were aware, from the outset.) Instead, they claim the vaccines are "safe and effective." However, contrary to what a vaccine is expected to do, these jabs neither prevent a person from catching the disease, nor from transmitting it to others. Yet, thousands of otherwise healthy persons have suffered serious injury or death, subsequent to receiving these vaccines.

Hundreds of medical doctors and scientists have spoken out against the necessity of these vaccines, citing vaccine dangers, and the availability of truly safe and effective treatment alternatives.

#### Several studies have shown that:

- Vaccinated people are actually more susceptible to contracting COVID variants than the unvaccinated.
- The death rate, especially among the young, is several times larger for those who receive the vaccines compared to those who contract the virus.
- Natural immunity is more robust and much longer lasting than the very limited immunity provided by these vaccines.
- Inexpensive, readily available medications and supplements are very effective for prevention and early treatment of COVID and all variants.
- The "all cause" death rate (among otherwise healthy, working age, people) increased by 40%, over prior years, in the year when vaccines became available. The 40% increase was originally reported by the CEO of OneAmerica Life Insurance Company, of Indiana). Since then, other companies and researchers have comfirmed that they are observing much higher increases. There was <u>no</u> increase in "all cause" deaths during the first year of the Covid-19 pandemic (prior to the vaccines). Knowing these things, a prudent person is wise to decline a jab.

SB-156 is necessary, to protect the legal right of individuals to informed consent (or rejection) of this and future government overreach.

I am writing to urge you to hear SB156 Covid Discrimination. I can personally attest that the letter of law is not being followed by companies doing business in Alaska. I am a project manager in Alaska for the past 15 years, most of my time in rural Alaska.

I am personally being harassed daily, threatened with job loss, and discriminated against because of my unwillingness to disclose my vaccination status. I am not anti-vax. I support Americans' right to choose their medical interventions and not be forced, coerced, or mandated into a decision.

The argument I have heard against this bill is that it prevents businesses from making their own decisions. That is not the essence of the bill. Large businesses are actively discriminating against Alaskan every day. My wife was terminated from her position and may never be able to work again in her chosen field. This virus has proven to be mutating to a less than a deadly seasonal annoyance. Government must promote public health, but the single sentence in the Alaska Constitution does not grant ultimate authority to allow mandates, forced mandates, or threat of social discrimination due to medical choices.

I will be calling in and following this bill closely. I will be tracking this bill and those that are for medical discrimination and the further perpetuation of government intervention into our lives.
