Madam Chair and members of the committee, and Senator Stevens,

Hello, my name is Robbi Mixon. While I reside in Homer, I am writing today from Kodiak, Alaska, where I'm working with an incredible group of Alaska Native farmers who are working to build greater food security for their villages through farming, hydroponics, and mariculture.

Today I am representing Alaska Food Policy Council, where I've served as Executive Director for the past 2.5 years and as a board member for 2 years prior.

We are a nonprofit organization committed to making improvements to Alaska's food system. Over 175 agencies and individuals representing federal and state agencies, tribal entities, schools, university programs, farmers, fisheries, and food systems businesses are represented by the AFPC. Our goal is to create a healthier, more secure, and more self-reliant Alaska by improving our food system.

Though we are small in staff - with just one part-time employee, we are mighty in reach and expertise. AFPC maintains several statewide working groups, like the Food Waste Committee and Indigenous Foods Working Group, that examine different parts of the food system. In 2020 we received a USDA Regional Food System Partnership Grant.

Our project, *Growing Connections and Building Networks for Greater Food Security* aims to connect localized food system organizations by creating a statewide network of "regional nodes." Through direct facilitation, each node was guided through a series of planning discussions, including community and region-based asset mapping to identify unique capacities for local food systems, while revealing barriers and system deficiencies.

By looking at how parts are connected throughout the food system, we are identifying ways to leverage assets in a community and beyond, while creating or identifying inventories of food systems capital- from financial and social, to infrastructure and governance leverage existing food system assessments.

Through regular statewide connection, communication, and collaboration, these regional nodes have begun to collectively identify linkages and partnerships which will be leveraged to create a preliminary 10-year statewide food security action plan, to help guide the work of the Alaska Food Policy Council and other food organizations. This plan will also help inform the work of the task force, translating these broad policy recommendations into specific policies and regulations.

AFPC is capable of providing support and structure to this Task Force, should we have the honor of doing so. We have been training and preparing for this for over a decade. Our USDA project, coupled with AFPC's research, committee activities, outreach, and convening capabilities, can directly support and complement the work of an Alaska Food Strategy Task Force, along with the work to be conducted by Governor Dunleavy's Food Security Task Force, forming in the next couple of weeks.

I commend the Governor's Administration Order and view HB298 as a continuation of the work ahead of us, and will provide more time and scope, and increased stakeholder input. In order to achieve economic independence and self-sufficiency, this must be an ongoing and long-term effort.

The past two years have revealed more clearly than ever a tremendous lack of security within our Alaskan food system - shipping delays, food waste, increased hunger, and not enough local production to feed our citizens, to name a few of the symptoms.

We have great challenges ahead of us, truly hope that this proposed task force can help lay the groundwork to transform our food system into a more localized, inclusive, equitable, and sustainable one. Through the collaboration from stakeholders across Alaska's food system, recommendations on policy, programs, and investments can help achieve this. The formation of a diverse and far-reaching food security task force would offer Alaska a chance to move toward greater food security for all Alaskans. We are in full support of HB 298.
