A BILL

FOR AN ACT ENTITLED

1 "An Act relating to biennial registration of motor vehicles; imposing biennial
2 registration fees on motor vehicles and setting the statutory amounts of a
3 scheduled biennial municipal tax on motor vehicles; relating to motor vehicle
4 emissions control programs; amending the effective date in sec. 7, ch. 56, SLA
5 1995; and providing for an effective date."

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

7 * **Section 1.** AS 28.10.108(b) is amended to read:

8 (b) Subject to the provisions of (f) of this section, a vehicle subject to
9 registration

10 (1) under AS 28.10.011 and 28.10.421(b)(3) and (4) and (c)(1) - (4)
11 shall have its initial registration, and may have its biennial [ANNUAL] registration,
12 renewed during the month of December;

13 (2) under AS 28.10.181, 28.10.411, and 28.10.421(d)(3) and (8) [(9)]

1 shall have its initial registration, and may have its **biennial** [ANNUAL] registration,
2 renewed during the month of January.

3 * **Sec. 2.** AS 28.10.108(c) is amended to read:

4 (c) A vehicle subject to registration and not described in (b) of this section
5 shall have its initial registration, and may have its **biennial** [ANNUAL] registration,
6 renewed in the month of initial registration in the state, subject to the provisions of (f)
7 of this section.

8 * **Sec. 3.** AS 28.10.108(d) is amended to read:

9 (d) A registered vehicle retains the same **biennial** [ANNUAL] expiration date
10 regardless of the ownership of the vehicle.

11 * **Sec. 4.** AS 28.10.108(f) is amended to read:

12 (f) Upon request of the owner and payment of the proportionate prorated
13 applicable fees, a vehicle registered under this section shall have its registration period
14 extended in monthly increments to allow **biennial** [ANNUAL] registration to occur in
15 the month of the owner's choice. Notwithstanding the other provisions of this
16 chapter, upon request of the owner and payment of the annual fee set out in
17 AS 28.10.421(h), the department shall register a rental motor vehicle for a one-
18 year period.

20 (b) The department may receive an application for the renewal of vehicle
21 registration and issue a new certificate of registration at any time before the expiration
22 of the **biennial** [ANNUAL] registration as prescribed in regulations adopted by the
23 commissioner. Nothing in this section prevents the commissioner from providing for
24 a longer [MULTI-YEAR] registration period; however, a person may not display the
25 new registration plates on a vehicle before a date which may be set by the
26 commissioner.

27 * **Sec. 6.** AS 28.10.411(a) is amended to read:

28 (a) For every year during any part of which a vehicle is subject to registration
29 under this chapter, a registration fee shall be paid to the department at the time of
30 original registration and at each **biennial** [ANNUAL] renewal of registration after that
31 time.

* **Sec. 7.** AS 28.10.411(f) is amended to read:

(f) A resident 65 years of age or older on January 1 of the year the vehicle is registered is entitled to an exemption once each **biennial registration period** [CALENDAR YEAR] from the registration fee required under this section for one motor vehicle subject to registration under AS 28.10.421(b)(1), (2), (5), or (6). An exemption may not be granted except upon written application for the exemption on a form prescribed by the department.

(b) The biennial [ANNUAL] registration fees under this subsection are imposed within the following classifications for:

(1) a passenger vehicle or motor home not used or maintained for the transportation of persons or property for hire or for other commercial use

(2) a pick-up truck or a van not exceeding 6,000 pounds unladen weight and not used or maintained for the transportation of persons or property for hire or for other commercial use **\$78** [\$40];

(3) a taxicab \$138 [\$70];

(4) a motor bus with a seating capacity for 20 or more persons and used exclusively for commercial purposes in the transporting of visitors or tourists

\$168 [\\$85];

(5) a motorcycle or a motor-driven cycle **\$38** [\$20];
(6) a trailer not used or maintained for the transportation of persons or

for hire or for other commercial use, including, but not limited to, a boat

trailer, baggage trailer, box trailer, utility trailer, house trailer, travel trailer, or a trailer rented or offered for rent **\$10** [\$5].

(c) The biennial [ANNUAL] registration fees under this subsection are imposed and are based upon the actual unladen weight as established by the manufacturer's advertised weight or upon the actual weight which the owner shall furnish, subject to the approval of the commissioner or the commissioner's representative, for a vehicle, including a motor vehicle pulling a trailer or semi-trailer,

1 that is registered in the name of a company or business, or is used or maintained for
2 the transportation of passengers for hire, excepting taxicabs and buses under (b) of this
3 section, or for the transportation of property for hire or for other commercial purposes,
4 including a trailer, semi-trailer, truck, wrecker, tow car, hearse, ambulance, and tractor,
5 as follows

- 6 (1) up to and including 5,000 pounds **\$100** [\$51];
- 7 (2) more than 5,000 pounds to and including 12,000 pounds
8 **\$170** [\$86];
- 9 (3) more than 12,000 pounds to and including 18,000 pounds
10 **\$310** [\$156];
- 11 (4) more than 18,000 pounds **\$440** [\$221].

13 (d) The special registration fees under this subsection are imposed **biennially**
14 [ANNUALLY], unless otherwise specified, for

- 15 (1) an historic vehicle, [() one time only upon initial registration under
16 AS 28.10.181 ()] \$10;
- 17 (2) special request plates for
 - 18 (A) Alaska National Guard personnel \$30;
 - 19 (B) veterans or retired veterans \$30;
 - 20 (C) recipients of the Purple Heart \$30;
 - 21 (D) owners of custom collection vehicles \$50;
 - 22 (E) other special request plates \$30;

23 plus the fee required for that vehicle under (b) of this section; the fee required by this
24 paragraph shall be collected only on the first issuance and on the replacement of
25 special request plates;

28 written application for an exemption on a form prescribed by the department none;

27 program established under AS 46.14.400 or 46.14.510. This fee shall be collected at
28 the same time and in the same manner as the registration fee.

18 system by January 1, 1998, and the remaining biennial vehicle registrations or renewals to be
19 imposed by January 1, 1999.

21 emissions inspection program imposed under ch. 56, SLA 1995, shall be imposed by a
22 municipality or the Department of Environmental Conservation in a manner that allows
23 approximately one-half of vehicle inspections to occur by January 1, 1998, and the remaining
24 emissions inspections to occur by January 1, 1999.
