A RESOLUTION

1 **Supporting the development of adequate in-state treatment capacity for severely**
2 **disturbed children.**

3 **BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

4 **WHEREAS**, on October 1, 2001, Alaska's Medicaid program funded over 300
5 severely emotionally disturbed Alaska children placed in out-of-state residential treatment
6 facilities by the Department of Health and Social Services or private parties; and

7 **WHEREAS** the total number of all types of licensed child residential beds in Alaska
8 is approximately 561, and only 108 of these beds provide the same level of treatment received
9 by severely emotionally disturbed children in out-of-state placements; and

10 **WHEREAS** the lack of in-state residential treatment beds clearly contributes to the
11 number of out-of-state placements; and

12 **WHEREAS** residential treatment beds are a critical component in the continuum of
13 treatment and care for severely emotionally disturbed children; and

14 **WHEREAS** providing residential treatment in Alaska allows for increased
15 involvement of a child's family, members of the child's support system, and involved
16 community providers in the child's treatment, thereby improving the quality of care and

1 leading to better outcomes, long-term success, and improved client satisfaction; and

2 **WHEREAS** subsequent placement in foster care, referral for other treatment, and
3 reintegration of the child back into Alaska communities can be more easily and quickly
4 achieved when a child is discharged from an in-state residential treatment facility, while
5 focusing on transition and a variety of local community-based services, in the child's home of
6 origin; and

7 **WHEREAS** development of residential treatment facilities in Alaska will create local
8 construction and institutional jobs;

9 **BE IT RESOLVED** that the Alaska State Legislature respectfully requests the
10 governor to direct the Department of Health and Social Services to work in conjunction with
11 the Alaska Mental Health Board, the Alaska Mental Health Trust Authority, and other
12 interested parties to strengthen the full continuum of residential and community-based care
13 and to work in a coordinated, cooperative, collaborative, and partnering manner towards
14 integration of services in Alaska for the treatment of severely emotionally disturbed children;
15 and be it

16 **FURTHER RESOLVED** that the Alaska State Legislature respectfully requests the
17 governor to encourage the Department of Health and Social Services, the Alaska Mental
18 Health Board, the Alaska Mental Health Trust Authority, and other interested parties to
19 establish as a priority the development of sufficient in-state residential care to serve severely
20 emotionally disturbed children who would otherwise be placed in out-of-state facilities.
