**IN THE LEGISLATURE OF THE STATE OF ALASKA**

**A RESOLUTION**

**1 Requesting the United States Congress to accommodate Alaska's wetlands**  
**2 circumstances in the federal Clean Water Act reauthorization by increasing**  
**3 statutory flexibility on wetlands use in Alaska, and to recognize Alaska's unique**  
**4 and outstanding history of wetlands conservation.**

**5 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

**6 WHEREAS**, in 1972, the federal Clean Water Act (33 U.S.C. 1251-1387) allowed a  
**7 broad expansion of federal jurisdiction over wetlands by modifying the definition of navigable**  
**8 waters to include all waters of the United States; and**

**9 WHEREAS**, in 1975, the United States Army Corps of Engineers expanded wetlands  
**10 regulations to include restricted discharge of dredged and fill material into wetlands; and**

**11 WHEREAS** wetlands regulations have been expanded further to include isolated  
**12 wetlands and those not adjacent to navigable waters; and**

**13 WHEREAS** the expansion of the regulations governing wetlands by federal agencies  
**14 exceeds what the Congress intended when it enacted the federal Clean Water Act; and**

**15 WHEREAS** Alaska contains more wetlands than all other states combined; and

**16 WHEREAS**, according to the United States Fish and Wildlife Service, approximately

1 170,200,000 acres of wetlands existed in Alaska in the 1780s and approximately 170,000,000  
2 acres of wetlands exist today, representing a loss rate of less than 1/10th of one percent in a  
3 decade through human and natural processes; and

4 **WHEREAS** approximately 98 percent of all Alaska communities, including 200 of 209  
5 remote villages in Alaska, are located in or adjacent to wetlands; and

6 **WHEREAS** with negligible benefit to the environment in Alaska, the expansion of  
7 wetlands regulations has placed an increasing and unnecessary burden on private landowners,  
8 Native organizations, and local and state governments by inhibiting reasonable community  
9 growth and environmentally benign, sensitive resource development; and

10 **WHEREAS** 88 percent of Alaska's wetlands are publicly owned, while only 26 percent  
11 of wetlands in the contiguous 48 states are in public ownership; and

12 **WHEREAS** more than 60,000,000 acres of Alaska's wetlands are known to be  
13 conserved in some form of land designation, including federally designated wilderness land,  
14 federal park and refuge land, and state park and refuge land, that restrict utilization or  
15 degradation of wetlands;

16 **BE IT RESOLVED** that the Alaska State Legislature respectfully requests the United  
17 States Congress to exclude Alaska from a "no net loss" policy associated with the federal  
18 Clean Water Act, and to amend the federal Clean Water Act to modify the wetlands regulatory  
19 program

20 (1) to provide flexibility in Alaska wetlands permitting commensurate with the  
21 large amount of wetlands set aside in Alaska and the low historic rate of wetlands loss in  
22 Alaska; and

23 (2) to relax the restrictions on the use of wetlands in Alaska; and be it

24 **FURTHER RESOLVED** that the Alaska State Legislature respectfully requests the  
25 United States Congress to recognize the unique contribution the citizens of Alaska have made  
26 to wetlands conservation and Alaska's outstanding record of wetlands conservation.

2 of the U.S. House of Representatives; to the Honorable John N. Chafee, Chair of the Senate  
3 Committee on Environment and Public Works; to the Honorable Bud Shuster, Chair of the  
4 House Transportation and Infrastructure Committee; to the chairs of the following  
5 subcommittees of the Senate Committee on Environment and Public Works: the  
6 Subcommittee on Transportation and Infrastructure; the Subcommittee on Superfund, Waste  
7 Control, and Risk Assessment; the Subcommittee on Clean Air, Wetlands, Private Property,  
8 and Nuclear Safety; and the Subcommittee on Drinking Water, Fisheries, and Wildlife; and  
9 to the Honorable Ted Stevens and the Honorable Frank Murkowski, U.S. Senators, and the  
10 Honorable Don Young, U.S. Representative, members of the Alaska delegation in Congress.
