A RESOLUTION

1 Relating to mandates imposed on the states by the federal government.

2 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF ALASKA:

3	WHEREAS the Tenth Amendment to the Constitution of the United States states:
4	"The powers not delegated to the United States by the
5	Constitution, nor prohibited by it to the States, are reserved to
6	the States respectively, or to the people."; and
7	WHEREAS the Tenth Amendment defines the total scope of federal power as being
8	that specifically granted by the United States Constitution and no more; and
9	WHEREAS the scope of power defined by the Tenth Amendment means that the
10	federal government was created by the states specifically to be an agent of the states; and
11	WHEREAS, today, the states are demonstrably treated as agents of the federal
12	government; and
13	WHEREAS many federal mandates are directly in violation of the Tenth Amendment;
14	and
15	WHEREAS the United States Supreme Court has ruled in New York v. United States,
16	112 S.Ct. 2408 (1992), that the Congress may not simply commandeer the legislative

1	processes of the states; and
2	WHEREAS a number of proposals now pending before the Congress may further
3	violate the Tenth Amendment of the United States Constitution; and
4	WHEREAS numerous resolutions addressing various mandates imposed on the states
5	by federal law have been sent to the federal government by the Alaska State Legislature
6	without any response or result; and
7	WHEREAS the United States Constitution envisions sovereign states and guarantees
8	the states a republican form of government; and
9	WHEREAS Alaska and its municipalities are losing their power to act on behalf of
10	state citizens as the power of government is moving farther away from the people into the
11	hands of federal agencies composed of officials who are not elected and who are unaware of
12	the needs of Alaska and the other states; and
13	WHEREAS the federal court system affords a means to liberate the states from the
14	grips of federal mandates;
15	BE IT RESOLVED that the Alaska State Legislature hereby claims sovereignty under
16	the Tenth Amendment to the Constitution of the United States over all powers not otherwise
17	enumerated and granted to the federal government by that constitution; and be it
18	FURTHER RESOLVED that this resolution serves as notice and demand to the
19	federal government to cease and desist, effective immediately, imposing mandates on the states
20	that are beyond the scope of its constitutionally delegated powers; and be it
21	FURTHER RESOLVED that the Governor is respectfully requested to examine and
22	challenge by legal action on behalf of the state, federal mandates contained in court rulings,
23	federal laws and regulations, or federal practices to the extent those mandates infringe on the
24	sovereignty of Alaska or the state's authority over issues affecting its citizens; and be it
25	FURTHER RESOLVED that Alaska's sister states are urged to participate in any
26	legal action brought under this resolution.

28	United States; the Honorable Al Gore, Jr., Vice-President of the United States and President
29	of the U.S. Senate; the Honorable Strom Thurmond, President Pro Tempore of the U.S.
