- "An Act relating to concealed handgun permittees." 1
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA: 2
- 3 * **Section 1.** AS 18.65.748 is amended to read:
- 4 Sec. 18.65.748. Permit holders from other jurisdictions considered Alaska 5 **permit holders.** A person holding a valid permit to carry a concealed handgun from 6 another state or a political subdivision of another state
- [(1) WITH PERMIT REQUIREMENTS SIMILAR TO THOSE IN 8 AS 18.65.700 - 18.65.790] is a permittee under AS 18.65.700(b) for purposes of 9 AS 18.65.750 - 18.65.765 if the person has not had an application for a concealed 10 handgun permit rejected in this state because the person was unqualified under 11 AS 18.65.705 or had a concealed handgun permit revoked or suspended by this state [BEEN IN ALASKA FOR MORE THAN 120 CONSECUTIVE DAYS; IN
