10 LEGISLATIVE APPROVAL REGARDING REFUNDING CERTAIN 11 OUTSTANDING BONDS. (a) The Alaska Industrial Development and Export Authority may 12 issue bonds for the purpose of refunding outstanding bonds issued August 18, 1998, as 13 authorized by sec. 25, ch. 111, SLA 1996, to finance the acquisition of the Snettisham
