#### Fifty-second Day

Pursuant to adjournment the House was called to order by Speaker Porter at 10:07 a.m.

Roll call showed 34 members present. Representatives Mulder and Whitaker had been previously excused from a call of the House today. Representative Wilson was excused from a call of the House today because of illness. Representatives Croft and Kott were absent and their presence was noted later. Representative Masek was absent.
