Joint Session in the House

Speaker Porter called the House to order and in accordance with Uniform Rule 51 turned the gavel over to President Halford at 3:13 p.m. The purpose of the Joint Session was to consider the Governor's vetoes.

The roll of the Senate was called and showed eighteen members present. Senator Davis was excused. Senator Kelly was absent.

The roll of the House was taken and showed thirty-eight members present. Representatives Berkowitz, Green were excused.

The presence of Senator Kelly was noted.

SB 363

Senator Leman moved that CONFERENCE CS FOR SENATE BILL NO. 363 "An Act relating to communications and elections, to reporting of contributions and expenditures, and to campaign misconduct in the second degree; relating to disclosure by individuals of contributions to candidates; and providing for an effective date" become law notwithstanding the Governor's veto. Senator Ellis objected.

The question being "Shall CONFERENCE CS FOR SENATE BILL NO. 363 become law notwithstanding the Governor's veto?" The roll of the House was taken with the following result:
