Insert "The task force shall have access to all information in the custody of the commission; however, information categorized as confidential shall be available to the task force only with the consent of the submitter of the information."

Page 6, line 30, add:

"**Sec. 11.** AS 42.04.080(c), (d) and (e) added by sec. 2 of this Act, and AS 42.04.090 added by sec. 3 of this Act are repealed on June 30, 2004."
