### **Forty-third Day**

The House was called to order by Speaker Kott at 11:37 a.m.

Roll call showed 34 members present. Representatives Kookesh and Whitaker had been previously excused from a call of the House today. Representative Moses was absent and his presence was noted later. There was one vacancy.
