### **One Hundred Nineteenth Day**

Pursuant to adjournment the House was called to order by Speaker Kott at 11:27 a.m.

Roll call showed 30 members present. Representative Croft had been previously excused (page 1721) from a call of the House. Representatives Berkowitz, Guttenberg, Harris, Kerttula, Kohring, McGuire, and Williams were absent and their presence was noted later. Representative Kapsner was absent and later excused.
