Roll call showed 33 members present. Representative Gruenberg was absent.

Representative Coghill moved and asked unanimous consent that Representatives Cissna, Croft, Elkins, Joule, Moses, and Neuman be excused from a call of the House today. There being no objection, it was so ordered.
