Upon being notified that a person is lost, injured, killed, or is in need of immediate rescue, <u>each of the following</u> [THE COMMISSIONER OF PUBLIC SAFETY OR A DESIGNEE] may appoint a competent person to organize, direct, and guide a search and rescue party <u>and may authorize a person to participate in a search and rescue party under this section:</u>

- (1) the commissioner of public safety or the commissioner's designee;
  - (2) a peace officer;
- (3) a fire fighter; in this paragraph, "fire fighter" has the meaning given in AS 09.65.295; or
- (4) a person authorized by a political subdivision of the state [FOR THE PURPOSE OF RESCUING OR RETRIEVING THE PERSON OR THE PERSON'S REMAINS]."
