## First Day

Pursuant to the provisions of the Constitution of the State of Alaska, the Uniform Rules of the Alaska State Legislature, and AS 24.05.160, the House of Representatives of the State of Alaska assembled in the House Chamber for the first regular session of the Twenty-sixth Alaska State Legislature, January 20, 2009, at 1:07 p.m., and was called to order by the Honorable Sean Parnell, Lieutenant Governor.

An Honor Guard from the Tongass Alaska Girl Scouts Council, composed of Sierra Coleman, Rachel Doogan, Chantel Eckland, Annika Pearson, Catriona Pearson, Summer Putman, Grace Terry, Aurora Ward, and Sommer Ward presented the Colors and led the Pledge of Allegiance.

The Alaska Youth Choir sang "Alaska's Flag" and "America the Beautiful" under the direction of Missouri Smyth.

The invocation was offered by the Chaplain, the Reverend Thomas Weise of Cathedral of the Nativity. Representative-elect Coghill moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.
