Pursuant to adjournment the House was called to order by Speaker Chenault at 10:32 a.m.

Roll call showed 34 members present. Representative Gatto had been excused from a call of the House today. Representatives Dick, Holmes, Johansen, and Stoltze were absent and their presence was noted later.
