The House was called to order by Speaker Chenault at 3:16 p.m. in the Terry Miller Legislative Office Building gymnasium.

Roll call showed 37 members present. Representative Ortiz had been excused from a call of the House today. Representative Colver was absent.

Representative Millett moved and asked unanimous consent that Representative Hawker be excused from a call of the House today. There being no objection, it was so ordered.

The invocation was offered by the Chaplain, Representative Herron. Representative Wilson moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.

"An Act relating to coverage under a state plan provided by the Comprehensive Health Insurance Association; establishing the Alaska comprehensive health insurance fund; relating to a reinsurance program; relating to the definition of 'residents who are high risks'; relating to an application for a waiver for state

innovation for health care insurance; and providing for an effective date."
