# **One Hundred Eighth Day**

Pursuant to adjournment the House was called to order by Speaker Edgmon at 10:44 a.m.

Roll call showed 36 members present. Representatives Chenault and Thompson had been excused from a call of the House today. Representatives Kreiss-Tomkins and Seaton were absent and their presence was noted later.

Representative Tuck moved and asked unanimous consent that Representative Thompson's excused absence (page 3473) be extended through 9:30 p.m., today. There being no objection, it was so ordered.

The invocation was offered by the Chaplain, Representative Tilton. Representative Ortiz moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.

With the deepest respect for the religious beliefs of all Alaskans, I offer the following prayer:
