Pursuant to adjournment the House was called to order by Speaker Edgmon at 10:34 a.m.

Roll call showed 36 members present. Representatives Hannan and Neuman had been excused from a call of the House today. Representative Carpenter was absent and his presence was noted later.

Representative Thompson moved and asked unanimous consent that Representative Claman be excused from a call of the House today. There being no objection, it was so ordered.

The invocation was offered by the Chaplain, Representative Tilton. Representative Shaw moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.
