JOINT SESSION IN THE HOUSE

In accordance with Uniform Rule 51 and an announcement by the presiding officers of an agreement to meet in Joint Session, Speaker Edgmon turned the gavel over to President Giessel who called the joint session to order at 11:11 a.m.
