Governor Dunleavy was welcomed by President Giessel.

Governor Dunleavy received a standing ovation.

Senator Costello moved and asked unanimous consent the Joint Session stand in adjournment. Without objection, President Giessel adjourned the Joint Session at 7:26 p.m.
