Second Reading of Senate Bills

SB 1002

SENATE BILL NO. 1002 "An Act making special appropriations for the payment of permanent fund dividends; and providing for an effective date" was read the second time.

Senators Hughes, Costello, Wilson, Wielechowski, Shower, Micciche, Reinbold offered Amendment No. 1:

Page 1, line 1:

Delete "special appropriations" Insert "a special appropriation"

Page 1, lines 4 - 12:

Delete all material and insert:

"* Section 1. ALASKA PERMANENT FUND. The amount authorized under AS 37.13.145(b) for transfer by the Alaska Permanent Fund Corporation on June 30, 2019, estimated to be \$1,944,000,000, is appropriated from the earnings reserve account (AS 37.13.145) to the dividend fund (AS 43.23.045(a)) for the payment of permanent fund dividends and for administrative and associated costs for the fiscal year ending June 30, 2020."

Senator Hughes moved for the adoption of Amendment No. 1. Senator von Imhof objected.

Senator Stedman rose to a point of order. President Giessel cautioned members to proceed in order.
