Without objection, the resolution was before the Senate on final passage.

Senator Costello offered Amendment No. 1:

Page 1, line 1, following "fund":

Insert "and the amount of the permanent fund dividend"

Page 2, following line 12:

Insert new material to read:

"FURTHER RESOLVED that the permanent fund dividend shall be distributed to residents in the amount calculated under AS 43.23.025 until the working group makes recommendations on the future use of the earnings of the Alaska permanent fund and those recommendations are passed by the Alaska State Legislature and signed into law by the governor; and be it"

Senator Costello moved for the adoption of Amendment No. 1. Objections were heard.

Senator Reinbold moved and asked unanimous consent to be added as a cosponsor on Amendment No. 1. Without objection, it was so ordered.
