Pursuant to adjournment the House was called to order by Speaker Stutes at 10:35 a.m.

Roll call showed 37 members present. Representatives Fields and McKay had been excused from a call of the House today. Representative Claman was absent.

The invocation was offered by the Chaplain, Representative McCabe. Representative Thompson moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.
