Pursuant to adjournment the House was called to order by Speaker Stutes at 10:31 a.m.

Inspire us to remember that each and every minute that we have here on earth is a precious and priceless gift.

We pray that we can chart a course forward toward justice and unity. To that end, we humbly pray for the strength to act with wisdom, with courage, and with compassion. Thank You.
