Pursuant to adjournment the House was called to order by Speaker Stutes at 10:30 a.m.

Roll call showed 38 members present. Representative Nelson had been excused from a call of the House today.

Representative Claman, Acting Majority Leader, moved and asked unanimous consent that Representative Tuck be excused from a call of the House today. There being no objection, it was so ordered.

The invocation was offered by the Chaplain, Representative Hannan. Representative Thompson moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.
