**Twenty-seventh Day**

The House was called to order by Speaker Stutes at 7:32 p.m.

Roll call showed 39 members present. Representative Rasmussen had been excused from a call of the House today.

The invocation was offered by the Chaplain, Representative Fields. Representative Thompson moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.
