Senator Giessel moved and asked unanimous consent that the roll call of the Senate be waived and all members be shown as present. There being no objection, it was so ordered.

Representative Saddler moved and asked unanimous consent that the roll call of the House be waived and all members be shown as present. There being no objection, it was so ordered.

President Stevens appointed Representative McCabe and Senator Wilson to escort the Governor to the joint session.

The Senate Sergeant-at-Arms announced the Governor's entrance into the House Chamber

Governor Dunleavy was escorted to the rostrum and welcomed by President Stevens.

Governor Dunleavy delivered his address, and it is published in Senate and House Joint Journal Supplement No. 2.

Governor Dunleavy received a standing ovation.

Senator Giessel moved and asked unanimous consent that the joint session adjourn. There being no objection, President Stevens adjourned the joint session at 7:49 p.m.

The Speaker ordered the House at ease to allow members of the Senate to leave the Chamber.
