## First Day

Pursuant to the Governor's proclamation dated May 17 calling the legislature into special session, the House was called to order by Speaker Tilton at 5:06 p.m.

Roll call showed 40 members present.

The invocation was offered by the Chaplain, Representative Armstrong. Representative Vance moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.

With the deepest respect for the religious beliefs of all Alaskans, I offer the following prayer:

In the spirit of love and justice for all, we remember the words of the Hebrew prophet Isaiah, who spoke these words from God not to individuals, but to the leaders of his nation:

"If you do away with the yoke of oppression, with the pointing finger and malicious talk, and if you spend yourselves in behalf of the hungry and satisfy the needs of the oppressed, then your light will rise in the darkness, and your night will become like the noonday."
