Pursuant to adjournment the Senate was called to order by President Stevens at 10:40 a.m.

The roll showed eighteen members present. Senator Wilson was excused from a call of the Senate. Senator Kawasaki was absent.

The prayer was offered by the Chaplain, Pastor Greg Weinert, Emmanuel Baptist Church. Senator Hoffman moved and asked unanimous consent the prayer be spread. Without objection, it was so ordered.
