Completed reading of PAS manual No. 5 "Legislative Department" Committee recommended unanimously that the Resolution regards "Location of State Capitol", presented by Chris Foulson, do not pass.

Proposal No. 11 referred back to the Convention with the recommendation that it should not become a part of the Constitution as it proposes matters that are transitory in nature and therefore should not become a part of the ~~Constitution~~ Constitution.

A discussion was held on the contents of the meeting at the proposed Televising of this Committee's meeting on Wednesday of the 23rd of November. It was generally agreed that the age qualifications of Electorate, and members of the House and Senate be one subject. Another subject to be the question of the merits and demerits of the Unicameral and bi-cameral Legislature.

MINUTES

COMMITTEE ON LEGISLATIVE BRANCH (NO. 6)

November 22, 1955  
(Tuesday)

The meeting was called to order by the Chairman, Steve McCutcheon at 1:40 pm.

All members were present.

The committee discussion was more varied dealing with a wider variety of subjects than heretofore discussed:

The possibility of securing the advisory services of Mr. Dayton D. McKean, one of the Consultants recommended by the PAS. It was agreed to see when and if he would be available for our use.

J. McNees led a discussion on the merits of Unicameralism which seems to have a growing interest by the Delegates as a whole.

Mr. McCutcheon provided the members of the committee with a study of the Legislative question to serve as a study guide.

Again in discussing the age and residence requirements of Legislators it was agreed that it would be age 30 and 5 yrs for the Senate, and age 23 and 3 yrs. for the House. If the Convention as a whole should approve Unicaeralism then it was thought that the age of 25 with 3 years residence would be recommended.

A discussion was held on Legislative Sessions and Mr. McCutcheon proposed: Session be 60 da. on odd years and 30 da. on even yrs. with any further extensions being authorized as follows: 3/5 for 10 da. extension, 2/3 for 20 da., 3/4 for 30 da., and 7/8 for 35 da. which would be a maximum. Special sessions called by either the Governor or the Legislative Council would require a 3/5 majority of all the members of the Legislature. No action was taken on the recommendation.

Mr. Winkel suggested a Legislative counsel of 5-11 members. No action was taken.

As a medium for setting Legislators salaries the suggestion was made that either the 'cost of living index' or the Chief Justice's salary be used as a guide. No action.

The meeting adjourned at 3:30 pm to hold their next regular meeting at the TV studio in the Northward bldg.
