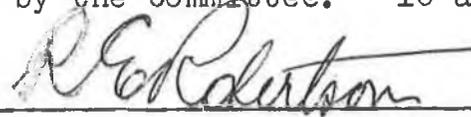
COMMITTEE ON RESOLUTIONS AND RECOMMENDATIONS

It was the sense of the meeting that a date for such T-V appearance be made for any day on or thereafter, and that at such hearing a general discussion be had as to the scope of this Committee's duties and of such possible yard-stick as it should use in passing upon the nature of Resolutions and Recommendations referred to it. Chairman Cross stated that President Egan evinced the attitude that a definitive yard-stick could not readily be made, but each Recommendation and Resolution must be determined as to its nature and whether referable to this Committee, as it was presented.

Douglas Gray moved, Leslie Nerland, seconded, which was unanimously carried that a further study be made of Proposal No. 10, and that its proponent Delegate Victor Fischer, also ^{Emil} Mr. Sadiq, be invited to attend this Committee's meeting on the 23rd inst. to express their views on the proposal. 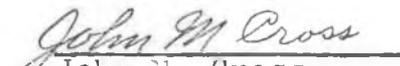

8. Leslie Merland moved, which was seconded and unanimously adopted, that all publicity matters pertaining to the Committee be handled by the Secretary with the approval of the Chairman.

10. Upon motion, duly made, seconded, and unanimously adopted, the Committee then adjourned subject to call of the Chairman for transaction of any business that may arise to come before the Committee.

Minutes of the Sixth Meeting

1. Meeting convened in Committee room at 9:30 a.m., November 26, 1955, Chairman Cross presiding. All members were present except Delegate Chris Poulsen.
2. Minutes of last meeting read and approved.
3. Secretary Robertson informed Committee that original Minutes would be kept in Committee's locker room, third floor, and one permanently filed with Convention's Librarian.
4. Consultant Emil Sady appeared and advised the Committee he had ascertained that no state had a constitutional provision such as contemplated by Proposal #10; that the New Jersey constitutional convention had a proposal somewhat similar to Article XI, Section 1100 of the Model Constitution before it, but had not adopted it; that there was no agreement among experts regarding the wisdom of providing by statute, as some states have done, that Federal aid to cities should be channeled through state agencies; and that he thought that a constitutional provision on the subject should not be stated in negative terms. At request, Mr. Sady reduced his advice to writing as follows:

"a. An examination of state constitutions in the Convention library reveals that none contains a provision such as Article XIV, Section 5 of the Hawaii constitution, dealing generally with intergovernmental relations. This suggests that such a provision is not required in order to permit the state and its

political subdivisions to participate in intergovernmental programs. However, in the absence of a provision such as that being considered (i.e. "The state and its political subdivisions may cooperate with the United States and its territories, and with the states and their political subdivisions on matters of common interest."), the State legislature of Alaska would have power to prevent or obstruct participation by local political subdivisions in Federal grant-in-aid programs. It should be mentioned in passing that Proposal 10 seems defective because it would specifically grant the legislature such power. While the above-quoted language would not prohibit a State legislature from regulating intergovernmental relations of State and local governments, it should serve to discourage legislation designed to prevent or obstruct cooperation.

"b. It is noteworthy that Federal grant-in-aid programs have increased steadily in recent decades. This trend is likely to continue. Some experts in government view with concern the development through several grant programs of direct relations between the Federal Government and cities or other local government units. Others accept the need and desirability of cooperation between governmental units at various levels, including direct Federal-city relations. I incline toward the latter view mainly because it avoids unnecessary red-tape and also because jurisdictions should have power commensurate with their responsibility. For example, if a state makes civil airport construction wholly a city responsibility, the State legislature should not be in a position to obstruct efforts by the city to participate

in Federal grant programs in that field.

"c. The issue facing the committee thus appears to narrow down to whether the people should, through the State constitution, set the general tone or policy regarding the relationship of their State and local government units with Federal and other levels of government in the U.S. or whether the constitution should be silent on the subject, allowing the State legislature greater freedom to control the relationships of political entities in Alaska with those in the States."

Mr. Robertson informed the Committee that the Judiciary Branch Committee had requested the attendance on December 1, 1955, of Sheldon Elliott, a Constitution lawyer, to advise on Constitutional Questions and his services could be obtained for this committee. After general discussion it was agreed that further consideration of Proposal #10 be deferred until the Committee could obtain Mr. Elliott's advice probably about December 1st.

5. No further business coming before the Committee it adjourned at 10:15 a.m. until 9:30 a.m., November 28, 1955.

Delegate McCutcheon appeared and stated his agreement to this Committee considering Proposal No. 10 and Delegate Poulsen's aforesaid Resolution, both of which had been referred by the President to Committee XII on Local Government of which Mr. McCutcheon is Chairman and that he would instruct the Secretary of Committee XII today to refer Proposal No. 10 and Delegate Poulsen's Resolution to this Committee for consideration.
