Analysis

This legislation amends AS 14.40.170 to add required University of Alaska Board of Regents communications to students regarding new or increased student fees and itemized billing statements.

The University of Alaska Board of Regents Student Fee policy (P05.10.070), regulations (R05.10.070), and university practices include expectations for student fee communications as envisioned by this legislation. The University does not expect additional costs to comply with the legislation.
