STATE OF ALASKA 2025 LEGISLATIVE SESSION

BILL NO. SB 83

Analysis

This bill amends AS 21.42 by adding a new section, AS 21.42.450, so that a health care insurer shall reimburse a health care provider for health care services provided through telehealth on the same basis or at least the same rate comparable for health care services provided in person. This bill will also allow group health insurance policy covering employees of a participating governmental unit or active State employees to meet the requirements of the new aforementioned section.

The Division of Insurance does not anticipate fiscal impact from this legislation.
